#### **Transportation Policy and Advocacy**

We advocate at all levels of government, including before Congress and federal and state executive branch agencies, to monitor, review, and engage in the development of legislation and policy in support of our clients' interests.

### **Transportation Regulatory Engagement and Compliance**

We assist clients with various transportation-related regulatory and guidance matters, involving surface transportation, motor carriers, pipelines, aviation and hazardous materials, where we routinely engage with the DOT and its agencies (FHWA, FTA, FAA, FMCSA, FRA, NHTSA, and PHMSA), as well as other federal agencies, including the U.S. Environmental Protection Agency (EPA), Transportation Security Administration (TSA) and the Office of Management and Budget (OMB), along with state, and local officials involved in transportation matters. Our team includes former DOT officials and regulatory lawyers well versed in the regulatory process.

#### **Transportation Project Development, Permitting and Environmental Reviews**

We understand the broad range of laws and regulations applicable to these major transportation projects, including, among others, the National Environmental Policy Act (NEPA), the Clean Water Act (CWA), the Endangered Species Act (ESA), Section 106 of the National Historic Preservation Act, and Section 4(f) of the Department of Transportation Act, and regularly advise on environmental review and permitting, planning, procurement, project design and construction requirements.
