Committee members also are tasked with looking at the “big picture”—they are encouraged to discuss AILA’s current publications offerings, suggest improvements, suggest potential new titles, and assist in planning and development of those. In addition, committee member feedback may be sought in connection with AILALink—AILA’s online immigration research database.
