Christina D. Bonanni, partner and member of Lippes Mathias' environment & energy practice team, moderated a panel at the Women's Bar Association of the District of Columbia's Energy & Environmental Law Forum titled Clean Energy Hubs: Everything You Need to Know. The panel, which included Suzanne Baker (stakeholder engagement specialist, U.S. Department of Energy Office of Clean Energy Demonstrations), Nichole Saunders (director & senior attorney, energy transition, Environmental Defense Fund), and Laura Goins (DEIA lead, NEPA subject matter expert, and general counsel for Allegheny Science and Technology), discussed the promise of the \$7 billion Regional Clean Hydrogen Hubs Program (H2Hubs) to speed commercial-scale deployment of clean hydrogen, generate clean, dispatchable power, create a new form of energy storage, and decarbonize heavy industry and transportation. The panel also explored how to avoid some of the potential costs and addressed some communities' concerns about increased local pollution and safety issues.
