She is also involved with the Mentor Connector Program, a charitable organization that supports youth in Southern Vermont.

Myrtle, an associate attorney who has joined the firm's Indian law practice team, advises tribal clients on issues ranging from gaming and economic development to self-governance and self-determination, along with claims settlement and litigation. Prior to coming to Lippes Mathias, she served as a judicial law clerk with the Mashantucket Pequot Tribal Nation where she drafted bench memorandums for criminal, civil, and family court proceedings; analyzed complaints, petitions, and motions to the court; and drafted final orders and judicial decisions. Myrtle has also interned with the Catawba Nation, drafting legislative ordinances for the tribe regarding its governmental transparency, family/medical leave, and disability policy.

Myrtle is a member of the Connecticut Bar Association and the Mashantucket Pequot Bar Association. She graduated from Rhode Island College in 2019 with her B.A. and in 2022, received her J.D. from the University of South Carolina School of Law.
