**BUFFALO, N.Y.** –On Friday, July 16, 2021, employees based in Lippes Mathias' Buffalo, NY office gathered at Journey's End Refugee Service's Brewster Street Farm to assist with a variety of outdoor farming activities including watering, weeding, hoop house maintenance, planting, harvesting, and more. The initiative was the latest installment in Lippes Mathias' continued efforts to create positive change in the communities surrounding each of its offices.

## **About Journey's End Refugee Services**

Journey's End Refugee Services, Inc. is a Christian community-based organization with the mission of welcoming refugees without regard to ethnic origin or creed and to assist them to become healthy, independent, contributing members of the community.

## **About the Brewster Street Farm**

The Brewster Street Farm is located at 36 Brewster St. between Main St. and Fillmore Ave. This small urban farm is equipped with a high tunnel to provide season extension and training opportunities. All produce is grown by the refugee farmers in raised beds that they can call their own. Produce is sold through the CSA, Farmer's Markets, and local restaurants. Farmers also grow produce for themselves which they take home to their families. All produce is grown without the use of chemical pesticides and herbicides and sold within the immediate community at a low cost. Providing quality, chemical-free vegetables and herbs is an integral part of the program. The farm is located in a food desert of Buffalo, where there is little access to healthy foods. By having a CSA, selling at a nearby farmer's market, accepting food stamps, and providing families with vegetables they grow at no cost, this program is able to provide an ample amount of inexpensive healthy food.
