

## Lippes Mathias Moves to Larger Office Location in Rochester Citing Strong Growth Among Practice Areas, Attorneys

Several of the firm's practice teams, including banking & financial transactions, brownfield & superfund cleanup and redevelopment, and insurance recovery, counseling & litigation, have played an instrumental role in driving the office's growth and solidifying roots in the region.

The once one-man Rochester office that opened with partner Michael R. Overmyer has flourished sevenfold, boasting a roster that includes attorneys Megan N. Ha, David M. Knapp, Matthew V. Paris, Kevin T. Merriman, Amy

L. Reichhart, and Alexis B. Telga, plus eight full-time staff members.

“These are the types of problems that we’re grateful to have as a firm,” Kevin J. Cross, Lippes Mathias’ managing partner and chairman, said. “Two years in the Rochester market and our growth has already driven us to seek additional square footage. Yes, this move to a larger space in Rochester underscores our firm’s momentum and sustained growth, but it’s also a clear indicator of the trust and partnership our clients in the Rochester community have placed in not just us as a firm, but in the respective attorneys and team members in the region who have made this growth possible.”

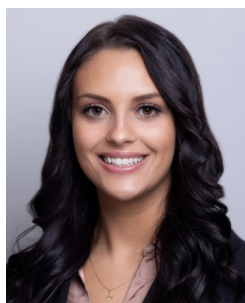
