BUFFALO, NY– On Monday, November 23, Lippes Mathias Wexler Friedman LLP Associate Attorney Lee M. Redeye will serve as a panelist for a virtual discussion organized by the University at Buffalo School of Law’s American Constitution Society. The panel, which is titled “Tribal Sovereignty: Understanding the Legality of Indigeneity,” is the final installment of the University at Buffalo School of Law American Constitution Society’s “statehood” series of webinars.

Lee and fellow panelists Barbara Creel and Lindsay Robertson will focus their discussion on relevant issues surrounding Tribal lands. The panel will introduce participants to Indigenous perspectives on legal issues centering on land rights, citizenship, and tribal sovereignty. The panelists will also highlight the recent case of *McGirt v. Oklahoma*, where the Supreme Court held that regarding the Major Crimes Act, much of the eastern portion of Oklahoma remains tribal land.

The complimentary panel will be held virtually via Zoom from 6:30-8:00 p.m. on Monday, November 23.

Lee focuses his practice on Indian law and commercial litigation matters. He has advised Tribes, and Tribal entities, in a wide range of matters from Treaty rights to corporate matters. He is a member of the Seneca Nation of Indians where he previously served as Chairman of the Board for the Nation’s economic development corporation, Chairman of the Board for the Constitution and Law Reform Subcommittee, a Peacemaker’s Court clerk, a Tribal Law Advocate, and a Law Clerk in the Department of Law.
