Tibbs presented at the Home Care Association of New York State Corporate Compliance Symposium, which was held on November 8, 2023, in Schenectady, N.Y. Carroll and Tibbs' presentation, titled "Artificial Intelligence in Home Healthcare and Legal and Compliance Issues," included a background discussion about the various types of artificial intelligence (AI), machine learning and automation applications and their related technologies and a review of the general legal authorities that apply to artificial intelligence and AI governance principles. The presentation also covered the additional legal requirements that apply to AI applications in healthcare, including existing and proposed standards issued by the Federal Drug Administration (FDA) and HHS Office of the National Coordinator for Health Information Technology and other legal requirements that are applicable, including the HIPAA Privacy and Security rules. Carroll and Tibbs also explored some areas of potential automation in home health care and reviewed associated legal issues.
