Alexander H. Wynkoop

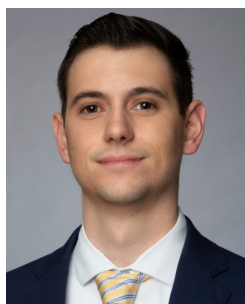
